
#### Introduction

Thailand Forest Certification Council (TFCC) is a organisation promoting sustainable forest management through Forest Management certification, Chain of Custody certification and labelling of forest based products.

The TFCC logo and labels provide information relating to the origin of forest-based products in sustainably managed TFCC certified forests, recycled and other non-controversial sources.

The TFCC Logo can only be used based on a TFCC Logo usage license issued by the Federation of Thai Industries (F.T.I.). All process will be operated by TFCC which is on behalf of FTI, based on TFCC Logo Usage Rules.

In terms of the organisational chart, TFCC is a part of the Institute of Agro-based Industries (I.A.I.) and acting as an authorized body of F.T.I.



#### 1 Scope

This TFCC PD 001 sets out the rules for the issuance of TFCC Logo use licenses, hereafter "licenses", by F.T.I. to ensure legally compliant use of the TFCC Logo in accordance with the TFCC Logo usage rules – requirements, TFCC SD 003.

F.T.I. is the TFCC Logo's owner to issue licenses to entities located in Thailand and sites in other countries, participating in a multi-site Chain of Custody certification with the central office being in Thailand.

#### 3 Terms and Definitions

#### 3.1 Accredited certificate

A certificate issued by a certification body within the scope of its accreditation, which bears the accreditation body's symbol.

#### 3.2 TFCC recognised certificate

- a valid, accredited Forest Management certificate of a certification body notified by TFCC, issued against TIS 14061, Sustainable Forest Plantation Management - Requirements of the Thailand Forest Certification System (TFCS) to an entity registered in Thailand.
- b) a valid, accredited Chain of Custody certificate of a certification body notified by TFCC, issued against the international PEFC Chain of Custody standard PEFC ST 2002, Chain of Custody of Forest Based Products – Requirements or TIS 2861, Chain of Custody – Requirement of the TFCS to an entity registered in Thailand.

#### 4 Conditions for the issuance of licenses

#### 4.1 General conditions

An entity applying for the license shall

- a) be a legal entity,
- b) agree that the entity's identification and other information as specified by the TFCC are publicly available on the web based PEFC Information and Registration System and TFCC website.

#### 4.2 Special conditions

User group B: Forest owners/managers, shall

- a) hold a valid TFCC recognised Forest Management certificate, issued against a valid version of TIS 14061 of the TFCS.
- b) sign a TFCC Logo Use Contract with F.T.I., acting TFCC on its behalf (Appendix 1).

**User group C:** Forest related industries, shall


- a) hold a valid TFCC recognised Chain of Custody certificate, issued against a valid version of TIS 2861 of the TFCS or a valid version of PEFC Chain of Custody certificate.
- b) sign a TFCC Logo Use Contract with F.T.I., acting TFCC on its behalf (Appendix 1).
- The holder of multisite Chain of Custody certification with the central office being in Thailand can apply for a multi-license covering the whole or a part of the scope of the multi-site certification provided that:
- a) the central office and the sites are a part of a single legal entity or
- b) the central office and the sites are a part of a single company with a single management and organisational structure.

#### User group D: Other users, shall

- a) identify the purpose of the TFCC Logo use, which does not conflict with the objectives and good name of the TFCC,
- b) be registered in Thailand,
- c) sign a TFCC Logo Use Contract with F.T.I., acting TFCC on its behalf (Appendix 1).

#### 7. One - off Use of the TFCC Logo

TFCC may allow a one-off usage of the TFCC Logo for off - product purposes to users without an individual license (e.g. in newspapers, reports, publications, etc.) under the following conditions:

- a) the use shall not conflict the objectives of TFCC,
- b) the TFCC Logo shall be used without the license number,
- c) the disclaimer "Reproduced with the permission of PEFC" shall be used.

The application for the one-off use of the TFCC Logo is specified in Appendix 3.

#### **TFCC Logo Use Contract**

#### Between

(1) F.T.I., having its registered office at 60, New Rachadapisek Road, Klongtoey, 10110 Bangkok, Thailand

#### And

(2) [Logo user], hereafter the "logo user", having its registered office at [address].

Whereas the logo user is a logo user in the User Group [name of the User Group (i.e. B – Forest owners/managers, C – Forest related industries or D – Other users)] as defined in the TFCC Logo usage rules (TFCC SD 003), including the following sites:

Whereas the F.T.I. is the owner of and has the copyright on the TFCC Logo, which are registered trademarks;

Whereas the logo user is to be granted a TFCC Logo license with the number *TFCC/xx-xx* and to be allowed to use the TFCC Logo according to the TFCC Logo Use Rules;

Now, therefore the above said parties agree to the following:

#### Article 1: Definitions:

1. The TFCC Logo Use Rules

This is set of requirements for the use of the TFCC Logo defined in TFCC SD 003, which forms part of the contractual documentation. The latest edition of TFCC SD 003 (including any amendment) or the document which replaces TFCC SD 003 applies.

#### Article 2: Copyrights to the TFCC Logo

 For the avoidance of any doubt, the TFCC Logo is copyrighted material and a registered trademark owned by the F.T.I. The initials "TFCC" are also registered and covered by copyright. Unauthorised use of this copyrighted material is prohibited and may lead to legal action. The use of the TFCC Logo is regulated and governed by the F.T.I.

#### Article 3: Responsibilities of the Logo User

1. The logo user is obliged to use the TFCC Logo in accordance with the TFCC Logo Use Rules and together with a license number issued by F.T.I. so as to ensure that the logo user is identifiable.

 The logo user is obliged to inform TFCC Committee Secretary immediately and truthfully on any changes concerning logo user's identification data and certified status in case of logo user group B and C.

#### Article 4: Responsibilities of

- TFCC is obliged to provide the logo user with access to the TFCC Logo and labels within 15 working days after this contract was signed by the logo user and TFCC Committee Secretary.
- 2. TFCC is obliged to inform the logo user on any change of the regulations and documentation concerning TFCC Logo use, which affects this contract.

## Article 5: Penalty

- 1. In case of a logo use by the logo user which is not in accordance with the TFCC Logo Use Rules or this contract, F.T.I. may impose, in case of user group B and C, a contractual penalty of an amount being one-fifth the market value of the products to which the logo use relates, unless the logo user proves that such unauthorised use was unintentional. In the latter case, the penalty will be limited to 50,000 THB.
- F.T.I. has the right to alter the amount of the penalty demanded for use of the TFCC Logo in contravention of the contract. The change shall come into effect three months after the F.T.I. has informed the logo user, in writing, of the change.

## Article 6: Contract Termination

- 1. Either party may terminate this contract with three-month prior notice by registered letter.
- 2. F.T.I. may revoke this contract temporarily with immediate effect while a suspicion of contravention of the contract or the TFCC Logo Use Rules is being investigated. In case of suspicion, F.T.I. shall send the logo user a written request for an explanation and notification of the temporary revocation of the contract. The temporary revocation shall remain in effect for a maximum period of one month after the logo user has provided an explanation concerning the suspected misuse to F.T.I. which will examine the matter. F.T.I. may reverse a decision on the temporary revocation of the contract when the logo user has implemented corrective measures approved by F.T.I. and given F.T.I. notification that this has been done.
- 3. F.T.I. may terminate the contract with immediate effect if there are reasons to believe that

any of the terms of the contract or the TFCC Logo Use Rules are not being adhered to.

4. Withdrawal, suspension or expiry of the TFCC recognised Forest Management certificate, in case of logo user group B, or the TFCC recognised Chain of Custody certificate, in case of logo user group C, will result in automatic termination of the TFCC Logo license contract with effect on the same date as the withdrawal, suspension or expiry of the Forest Management or the Chain of Custody certificate.

#### Article 7: Reporting and Presentation

- 1. In case of logo user group C, the logo user shall provide F.T.I. immediately after each audit, with a summary of the on-product use of the TFCC Logo by the logo user, broken down by product, product category, production unit or similar, to the degree of accuracy that the Chain of Custody system used by the logo user permits. In addition the logo user shall supply F.T.I. with a detailed, free form account of any off-product use of the TFCC Logo.
- 2. In case of logo user group D, the logo user shall provide F.T.I. with an annual report containing a free form account of the off-product use of the TFCC Logo.

#### Article 8: Validity of the Contract

1. The contract enters into force when it was signed by the logo user and F.T.I.

#### Article 9: Other terms of the contract

- F.T.I. reserves the right to carry out (by itself or to commission a third party to act on its behalf) an on-site inspection of the logo user's operations, if it has received a complaint by third party, or if F.T.I. has reasons to believe that the contract is being contravened. The logo user shall bear responsibility for the costs of said inspection and any other detrimental effects.
- 2. The logo user, in case of the group B and C, undertakes to enter an agreement with the certification body within three months of signing this contract to that effect that, in conjunction with the audits conducted subsequent to signing this contract, certification body will examine the system by means of which the logo user keeps records of the production volumes marked with the TFCC Logo and how the Logo is used on them. The certification body shall have a right to inform the F.T.I. of changes of which it is aware,

without consulting the logo user.

## **Article 10: Arbitration**

- 1. This contract is subject to Thailand's law.
- 2. Any disputes arising out of this agreement shall be finally and exclusively settled by the courts of Thailand.


